#### OBJECTIVE

The Fund seeks total return, consisting of income and capital appreciation.

### FUND STRATEGY

The Fund invests principally in debt securities, including corporate, mortgage-and assetbacked securities, bank loans, foreign sovereign debt, supranational agencies, and U.S. Government obligations. These securities may have fixed, floating or variable rates and may include debt securities of both domestic and foreign issuers. The Advisor invests in both investmentgrade and below investment-grade debt securities (often called "high yield" securities or "junk bonds"), including unrated securities, as well as securities that are in default at the time of purchase. The Fund may invest in debt securities of foreign issuers, including emerging markets issuers. The Advisor may seek to add yield by having exposures to a variety of credits, mortgages, and higher yielding countries. The Advisor may also use futures and swap agreements to manage risk or to enhance return.

Weighted average coupon: The weighted average annual interest rate (expressed as a percentage of par value) that the issuers of all of the bonds in a fund promise to pay until maturity.

Weighted average effective maturity: For a portfolio of bonds, average effective maturity is the weighted average of the maturities of the underlying bonds. The maturities are computed by weighting each bond's maturity by its market value with respect to the portfolio and the likelihood of any of the bonds being called. In a pool of mortgages, this would also account for the likelihood of prepayments on the mortnanes

Effective duration: A duration calculation for bonds with embedded options. Effective duration takes into account that expected cash flows will fluctuate as interest rates change. Yield to maturity (YTM) is the total return anticipated on a bond if the bond is held until it matures.

#### **Risks**:
