- Seeks long-term capital appreciation.

- Uses a negative screen to exclude securities issued by companies based on their exposure to ESG risks.
- The fund may invest:

  - in up to 15% of total assets in equity securities of non-US issuers including through ADRs, CDRs, EDRs, GDRs, IDRs and similar depositary receipts
  - by using futures/derivatives for hedging or efficient portfolio management purposes
