What is this product?

Туре	Allspring (Lux) Worldwide Fund (the "Fund") is a Societe d'Investissement à Capital Variable (SICAV) composed of several separate sub-funds organised under the laws of Luxembourg.	
Term	The Fund has been established for an indefinite period of time. The PRIIP Manufacturer reserves the right to liquidate the Fund, subject to approval by the Board of Directors.	
Objectives	Allspring (Lux) Worldwide Fund - Climate Transition Global Investment Grade Credit Fund (the "Sub-Fund") seeks total return, maximising investment income while preserving capital by investing, under normal circumstances, at least two-thirds of its total assets in credit debt securities rated investment grade (i.e., BBB- and/or Baa- or equivalent and above from Standard & Poor's, Moody's or Fitch) at the time of purchase issued by corporate issuers domiciled anywhere in the world. The Sub-Fund promotes environmental and/or social characteristics but does not have a sustainable investment objective. The Sub-Fund invests up to one-third of its total assets in debt securities rated as distressed or lower) at the time of purchase as well as agencies and Supranationals, taxable municipals, sovereign bonds and up to 10% of its total assets in asset-backed securities including commercial mortgage-backed securities. The Sub-Fund may invest up to 5% of its total assets in contingent convertible bonds. The Sub-Fund will target to decarbonise by 2050. This is intended to be achieved by setting an initial decarbonisation profile for the Sub-Fund that has a carbon intensity that is at least 30% lower than the Bloomberg Global Aggregate Corporate Index (USD Hedged). The assets within the Sub-Fund are then managed such that the decarbonisation profile will decline annually with a trajectory to decarbonise by 2050. Through the use of a negative screening process, the Sub-Fund seeks to exclude certain securities in accordance with its exclusion policy.
