

What is this product?			
Туре	Allspring (Lux) Worldwide Fund (the "Fund") is a Societe d'Investissement à Capital Variable (SICAV) composed of several separate sub-funds organised under the laws of Luxembourg.		
Term	The Fund has been established for an indefinite period of time. The PRIIP Manufacturer reserves the right to liquidate the Fund, subject to approval by the Board of Directors.		
Objectives	Allspring (Lux) Worldwide Fund - EUR Short Duration Credit Fund (the "Sub-Fund") seeks to maximise investment income while preserving capital, by investing at least two-thirds of its total assets in Euro-denominated credit debt securities, rated investment grade at the time of purchase, issued by sovereign or corporate issuers. Investment grade means bearing a credit rating of BBB- and/or Baa3 or equivalent and above from any one of the following credit rating agencies: Standard & Poor's, Moody's or Fitch, where an investment is not rated by either Standard & Poor's, Moody's or Fitch and where the Sub-Investment Manager consults with such other external sources that are available and uses its professional judgement, supported by at least one external opinion that such investment is of investment grade rating. While the Sub-Fund may purchase securities of any maturity or duration, under normal circumstances, its average weighted duration is expected to be up to 3.5 years or less. The Sub-Fund promotes environmental and/or social characteristics but does not have a sustainable investment objective. The Sub-Fund may invest up to one-third of its total assets in currency-hedged non-Euro-denominated debt securities and foreign agencies; up to 10% of its total assets in debt securities rated below investment grade at the time of purchase; and up to 7.5% of its total assets in debt securities rated below investment grade at the time of purchase; and up to 7.5% of its total assets in contingent convertible bonds. The Sub-Fund will not invest in assets rated below B-/B3. In the case of a downgrade on an existing investment below B-/B3, the downgraded assets must be sold by the Sub-Fund in an orderly and timely manner in accordance with the general applicable principles. The Sub-Fund will ultilise the Allspring ESGiQ (ESC Information Quotient), a proprietary rating system created to assess ESG risk and materiality.
