What is this product?

Type	Allspring (Lux) Worldwide Fund (the "Fund") is a Societe d'Investissement à Capital Variable (SICAV) composed of several separate sub-funds organised under the laws of Luxembourg.
Term	The Fund has been established for an indefinite period of time. The PRIIP Manufacturer reserves the right to liquidate the Fund, subject to approval by the Board of Directors.

Allspring (Lux) Worldwide Sub-Sub-Fund - Climate Transition Global Investment Grade Credit Fund (the "Sub-Fund") seeks total return, maximising investment income while preserving capital by investing, under normal circumstances, at least two-thirds of its net assets in credit debt securities rated investment grade (i.e., BBB- and/or Baa- or equivalent and above from Standard & Poor's, Moody's or Fitch) at the time of purchase issued by corporate issuers domiciled anywhere in the world. The Sub-Fund promotes environmental and/or social characteristics but does not have a sustainable investment objective. The Sub-Fund invests up to one-third of its net assets in debt securities rated below investment grade (excluding securities rated as distressed or lower) at the time of purchase as well as agencies and Supranationals, taxable municipals, sovereign bonds and up to 10% of its net assets in asset-backed securities including commercial mortgage-backed securities. The Sub-Fund may invest up to 5% of its net assets in contingent convertible bonds. The Sub-Fund will target to decarbonise by 2050. This is intended to be achieved by setting an initial decarbonisation profile for the Sub-Fund that has a carbon intensity that is at least 30% lower than the Bloomberg Global Aggregate Corporate Index (USD Hedged). The net assets within the Sub-Fund are then managed such that the decarbonisation profile will decline annually with a trajectory to decarbonise by 2050. Through the use of a negative screening process, the Sub-Fund seeks to exclude certain securities in accordance with its exclusion policy. Shareholders may also request a copy from the Sub-Fund or the Management Company.

Objectives

The Sub-Fund will hedge non-US Dollar-denominated investments to the US Dollar. The Sub-Fund may also use futures, forward contracts, options, or swap agreements, as well as other derivatives, for hedging, efficient portfolio management or investment purposes.

The Sub-Fund focuses on bottom-up credit research with a focus on well-underwritten credits and relative value, with security selection as the primary driver of returns, and seeks to balance income while targeting a competitive yield to drive total returns. The Sub-Fund is actively managed but uses the Bloomberg Global Aggregate Corporate Index (USD Hedged) as a reference for selecting investments, performance comparison and carbon intensity comparison. The investments of the Sub-Fund may deviate significantly from the components of and their respective weightings in the benchmark.

You may redeem your investment upon demand on each business day when banks in Luxembourg are open for normal business and the New York Stock Exchange is open for trading (a "Business Day").

This share class does not distribute dividends. Income is reinvested in the Sub-Fund.

This share class will seek to be 100% hedged against the base currency of the Sub-Fund with the objective of minimising currency risk exposure. It may not be possible to always hedge the class 100% against fluctuations of the reference currency.

Intended investor

This product is intended for institutional investors of all knowledge and/or experience levels who are prepared to experience higher levels of volatility in pursuit of higher returns, who have an investment horizon of 5 years or longer and who have a risk tolerance compatible with the product's SRI rating.

What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products.
