What is the product?

Type: This product is a Société d'Investissement à Capital Variable (SICAV).

Term: The fund has been established for an indefinite period of time. The PRIIP Manufacturer reserves the right to liquidate the fund, subject to approval by the Board of Directors.

Objectives: The fund seeks total return, maximising investment income while preserving capital by investing, under normal circumstances, at least two-thirds of its total assets in credit debt securities rated investment grade (i.e., BBB- and/or Baa- or equivalent and above from Standard & Poor's, Moody's or Fitch) at the time of purchase issued by corporate issuers domiciled anywhere in the world. The fund promotes environmental and/or social characteristics but does not have sustainable investment objective. The fund invests up to one-third of its total assets in debt securities rated below investment grade (excluding securities rated as distressed or lower) at the time of purchase as well as agencies and Supranationals, taxable municipals, sovereign bonds and up to 10% of its total assets in asset-backed securities including commercial mortgage-backed securities. The fund may invest up to 5% of its total assets in contingent convertible bonds. The fund will target to decarbonise by 2050. This is intended to be achieved by setting an initial decarbonisation profile for the fund that has a carbon intensity that is at least 30% lower than the Bloomberg Global Aggregate Corporate Index (USD Hedged). The assets within the fund are then managed such that the decarbonisation profile will decline annually with a trajectory to decarbonise by 2050. Through the use of a negative screening process, the fund seeks to exclude certain securities in accordance with its exclusion policy. Shareholders may also request a copy from the fund or the Management Company. The fund will hedge non-US Dollar-denominated investments to the US Dollar. The fund may also use futures, forward contracts, options, or swap agreements, as well as other derivatives, for hedging, efficient portfolio management or investment purposes. The fund focuses on bottom-up credit research with a focus on well-underwritten cre

This product is intended for institutional investors of all knowledge and/or experience levels who are seeking more income with higher volatility in overall return and are looking to diversify their investments through exposure to global bonds, who have an investment horizon of 5 years or longer and who have a risk tolerance compatible with the product's SRI rating.

This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 4.68% before costs and 4.04% after costs.
