What is the product?

Type: This product is a Société d'Investissement à Capital Variable (SICAV).

Term: The fund has been established for an indefinite period of time. The PRIIP Manufacturer reserves the right to liquidate the fund, subject toapproval by the Board of Directors.

Objectives: The fund seeks long-term capital appreciation by investing at least two-thirds of its total assets in equity securities of U.S. companies of any size, and up to 25% of its total assets in equity securities of non-U.S. issuers through ADRs, CDRs, EDRs, GDRs, IDRs and similar depository receipts as well as U.S. dollar-denominated equity securities of non-U.S. issuers. U.S. equity securities are securities issued by companies with their principal office in the United States or exercising a predominant part of their economic activities in the United States. The fund promotes environmental and/or social characteristics but does not have a sustainable investment objective. The fund may invest in any sector, and at times it may emphasise one or more particular sectors. The fund may use futures, forward contracts, options or swap agreements, as well as other derivatives, for hedging or efficient portfolio management purposes. Through the use of a negative screening process, the fund seeks to exclude certain securities in accordance with its exclusion policy. When selecting securities for the portfolio, the fund believes strong ESG policies and practices contribute to a company's long-term sustainability of growth, a core tenet of its investment process that focuses on companies with robust, sustainable, and underappreciated growth. The fund will invest at least 64% of the fund's assets in companies that are perceived as strong ESG performers or companies with underappreciated ESG characteristics that can drive future growth consistent with its forward-looking expectations. The fund promotes and influences a company's ESG trajectory through engagement. The fund is actively managed but uses the Russell 3000® Growth Index for performance comparison.
