What is the product?

Type: This product is a Société d'Investissement à Capital Variable (SICAV).

Term: The fund has been established for an indefinite period of time. The PRIIP Manufacturer reserves the right to liquidate the fund, subject to approval by the Board of Directors.

Objectives: The fund seeks total return, consisting of a high level of current income and capital appreciation by investing, under normal market conditions, at least two-thirds of its total assets in corporate debt securities that are below-investment-grade (i.e., rated lower than Baa by Moody's or lower than BBB by Standard & Poor's or, if unrated, determined to be of comparable quality by the fund), at least 75% of its total assets in debt securities of U.S. issuers, up to 25% of its total assets in U.S. dollar-denominated debt securities of non-U.S. issuers, and up to 20% of its total assets in asset-backed securities. U. S. debt securities or services are securities: (1) issued by companies with their principal office in the United States or exercising a predominant part of their economic activities in the United States; or (2) issued by U.S. governmental issuers. The fund invests principally in below-investment-grade debt securities (often called "high yield" securities or "junk bonds") of U.S. corporate issuers that are rated BB through B by Standard & Poor's or Ba through B by Moody's or an equivalent quality rating from another U.S. nationally recognized statistical ratings organization, or are deemed by the fund to be of comparable quality. While the fund may purchase securities of any maturity, under normal circumstances, its U.S. dollar-weighted average effective maturity is expected to be three years or less.
